## Candidates' interview performance is the major assessment indicator.

The following factors will be taken into account if two candidates are considered equal in all other aspects.

- Father / Mother currently employed at the primary sections (located at the same address as the Kindergarten) / kindergarten sections of the School on a full-time basis
- Brother / Sister currently studying at the primary sections (located at the same address as the Kindergarten)/ kindergarten sections of the School
- Father / Mother is a school manager of the School
- Father / Mother or Brother / Sister is an alumnus of the primary sections / kindergarten sections of the School
- Candidates reaching school age (aged 2 years and 8 months to 4 years by September next year when school commences)
- Place of residence is close to the School

\*The above criteria are formulated with reference to the Discretionary Places Allocation Method of the Education Bureau and are in compliance with the Sex Discrimination Ordinance, Disability Discrimination Ordinance, Family Status Discrimination Ordinance, and Race Discrimination Ordinance.

- 1. A written letter of withdrawal has to be *submitted in person* to the School in the case of applying for withdrawal after the registration or admission procedures have been completed.
- Students wishing to discontinue their studies after 31<sup>st</sup> July 2025 have to notify the School in writing on or before the first day of the month before the official withdrawal date to proceed with the withdrawal process.
